Dogs entered in the Amateur-Owner-Handler class will automatically be marked as eligible to compete in the NOHS. Eligible dogs will be identified by an asterisk in the judge's book, steward's book & the catalog. Dogs must be handled throughout the breed level competition for the regular show by an eligible owner.

Current assistants that are eligible to compete in Junior Showmanship (meet age & amateur status requirements) may participate in NOHS.*

POINTS FOR RESERVE

Chapter 16 Section 1 Rules Applying to Dog Shows

... at the National Specialty the dog designated Reserve Winners Dog and the bitch designated Reserve Winners Bitch will be awarded a three-point major, provided that the number of dogs competing in the regular classes of the Reserve Winner's sex totals at least twice the number required for a five point major, in the region in which the event is held.

NON-REGULAR CLASSES INVOLVING SINGLE DOG ENTRIES

NR1.08100.02400. Veteran Classes - Class for dogs & class for bitches seven (7) years & under nine (9) years. Veteran Classes must meet all requirements to compete for Best of Breed.

NR1.08100.36800. Veteran Classes - Class for dogs & class for bitches nine (9) years & over. Veteran Classes must meet all requirements to compete for Best of Breed.

Entries in the Veteran Classes may be spayed or neutered. Winners of the above classes are eligible to compete in the Best of Breed Competition. **NOTE:** If a dog is entered in both a Veteran class and the Best of Breed class and is defeated in the Veteran class, the dog CANNOT be shown in Best of Breed.

00900. BEST OF BREED COMPETITION

NR2.09100. Stud Dog Class - For Stud Dogs and two of their Get. It is not necessary that the Get be under the same ownership as that of the Stud Dog. All participants MUST be entered in a Regular or another Non-Regular Class. The Stud Dog shall be considered as one entry and requires only one entry fee. The Stud Dog must be entered in the Stud Dog Class and shown in the ring with his Get. While the merits of the Stud Dog are not to be considered in the placement of the entry, the Stud Dog must be examined to determine if it has a condition that would require its disqualification or excusal under the Dog Show Rules, AKC policy, or the standard for its breed.

NR2.09200. Brood Bitch Class - Same as Stud Dog Class except substitute Brood Bitch for Stud Dog and Produce for Get.

As the judge's decision in the Stud Dog & Brood Bitch Classes will be based on the merits of more than one dog or bitch, no one of the dogs or bitches making up the entry judged first in the class will be eligible for Best of Breed Competition by virtue of having won these classes.

ATTENTION EXHIBITORS: Trophies, certificates, ribbons and prizes will be awarded in the ring to the person exhibiting the dog who shall be considered the owner or agent. All claims for prizes must be made in the judging ring before the completion of judging. The Superintendent and the show-giving club disclaim any liability for monetary prizes after the judging of the event is over. All trophies must be picked up on the day of the show. None will be mailed. The DDTCA reserves the right to substitute any prize listed for one of equal or greater value.

Junior Handlers who win a third Novice Class with competition present or a first place in Novice without competition leading to a Best Junior award with competition would count as one win towards moving to Open, after the closing of entries for a show, **ARE REQUIRED TO TRANSFER** their entry from the Novice Class to the Open Class. **MUST NOTIFY** the Superintendent/Show Secretary prior to the judging of the class at the show.

Juniors which according to their records have completed the requirements to compete in the Open Class but whose status is unconfirmed by the American Kennel Club are limited to competing in the Open Class for a period of 60 days from the date of the show where the Junior completed the requirements according to their records.

MASTER CLASS: This class will be for Boys and Girls who are at least 9 years old and under 18 years on the day of the show, and who have 10 Best Junior wins with competition. The calendar for this class will be consistent with the eligibility dates for the AKC National Championship. All Juniors meeting the criteria for this class are required to enter the Master Class and must change their entry the day of the show if entries have already closed. Once the eligibility time frame for that year has passed all participants return to the Open Class to compete for the following year.
